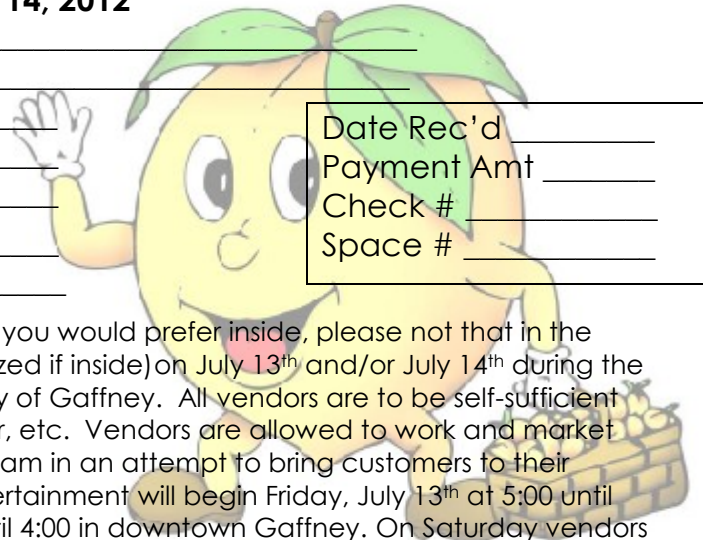

The cost is \$300 for a 15x15 space located outside (if you would prefer inside, please note that in the details below, also your 15x15 space may be downsized if inside) on July 13th and/or July 14th during the Downtown events of the SC Peach Festival in the City of Gaffney. All vendors are to be self-sufficient and must provide their own tents, table, chair, power, etc. Vendors are allowed to work and market their assigned location but are not allowed to free roam in an attempt to bring customers to their space. Set-up will begin at noon on Friday. The entertainment will begin Friday, July 13th at 5:00 until 10:00 and on Saturday, July 14th after the parade until 4:00 in downtown Gaffney. On Saturday vendors should be set up by 8am and be prepared to stay until 4 pm.

For and in consideration of permission to participate as a Commercial Vendor, I hereby irrevocably and forever release, discharge, waive, and hold harmless the South Carolina Peach Festival and its officers, directors, employees, sponsors, and volunteers (collectively referred to as "South Carolina Peach Festival") from any and all claims, losses, causes of action and liabilities of any kind (including attorney's fees) arising out of or relating in any way as a Commercial Vendor. I voluntarily waive any claims that I might have against the South Carolina Peach Festival, and I understand and agree that the South Carolina Peach Festival assume no responsibility or liability for any injury to persons or property (including property that is lost, stolen or damaged), that may occur. I agree that I am at least 18 years of age and am bound by all the terms of the Hold Harmless and Assumption of Risk Agreement. ENTRY FEES: Once you have been accepted as a vendor, **NO REFUNDS** will be issued for any reason. **Application deadline is June 22, 2012 or until spaces are full.** A confirmation will be sent via email or mail.

DEADLINE INFORMATION – Application deadline is Friday, June 22, 2012. There will be a late charge of \$25 for applications not postmarked by the June 22nd deadline – NO EXCEPTIONS!

VENDOR HOURS: Commercial Vendors will open to the public at 5:00 p.m. until 10:00 p.m. on Friday, July 13, 2012 and will run on Saturday immediately following the South Carolina Peach Festival Parade. The parade begins at 10:00 a.m. It is necessary for all vendors to be at their location no later than 8:00 a.m. to avoid road closures. When the roads are closed, they will not reopen before the scheduled time. Commercial Vendors will be allowed to operate until 4:00 p.m.

RESTRICTED ITEMS: Only authorized FOOD vendors are permitted to sell food and drinks. Unauthorized sale of food or drink items will result in automatically closing your booth for the remainder of the festival. We reserve the right to remove any items that have not been screened, is of poor quality or inappropriate. You are also not allowed to give away water as part of your display.

SALES: Vendors will retain all revenue from sales during the fest, and are responsible for all currency-related issues. Vendors are allowed to sell their merchandise within their leased space only. They may not walk into common/ pedestrian areas of festival site unless arrangements are made PRIOR to the event.

TAXES & PERMITS: Vendors are responsible for complying with local and state tax regulations. Your South Carolina Retail License number is *required* on your application. If you do not have a South Carolina Retail License, please contact the South Carolina Department of Revenue at 864-214-1200 or review the website at www.sctax.org. The South Carolina Peach Festival will secure a City of Gaffney Solicitation Permit for all vendors. Vendors are responsible for South Carolina licenses, permits, DHEC, and all taxes.

RAIN DATE/REFUND: There is no rain date for The South Carolina Peach Festival Family Fun Fest and there are no refunds due to inclement weather.
